Items:

- Guest Presentation TRAC
 - Sherri and Larry discussed the background, vision, benefits of membership, and the TRAC membership plan and commitment (see copy of their notes)
 - Main areas of discussion were the costs/benefits of TCL becoming TRAC member
 - Benefits to Membership TCL would have access to TRAC resources; including membership sales (the majority of TCL's memberships are done online), dedicated office hours at the TRC, and access to other community leagues resources.
 - Cost of Membership -Based on our membership TRAC is currently seeking \$7,000.
 In order to recoup this expense TRAC recommended TCL increase its annual membership by \$5/membership.
 - Other areas of discussion/items discussed were as follows:
 - Why is the fee structure a mandatory? With TCL being largest community league does not benefit TCL to pay based on # of memberships.
 - What is the likelihood of getting funding support from other community leagues of TRAC (ie: funding for the South T spray deck). None of their activities are joint, and currently they received \$6,500 in free advertising.
 - No clear benefit of joining TRAC; cannot support paying \$7,700 for an office space that TCL will not use
 - TCL to review the possibility to increasing the annual membership from \$42 to \$47 to offset costs of TRAC membership. This decision would need to be presented at the AGM in November
 - Motion: To add TRAC fees to budget to be presented at November AGM
 - Motion passed by a vote of 4 to 2
